Subject: Formal Notification — Supplemental Record Filed with Pennsylvania Office of Open Records | Docket No. 2026-0167

Members of the Octorara Area School District Board of Directors,
Superintendent,

This letter serves as formal notification that on May 28, 2026, I submitted a Notice of Supplemental Context to the Pennsylvania Office of Open Records under pending appeal Docket No. 2026-0167. Confirmation of receipt from the Office of Open Records is attached.

The submitted document is also attached to this letter in full.

The filing documents a sequence of events that occurred on May 28, 2026, involving posts published on X.com by the account @LondonderryX123, the issuance of a formal Cease and Desist notice to Board Director Brian P. Fox, notification to this Board, a retaliatory post published within approximately one hour of that notice, and the subsequent removal of posts before end of day.

Central to the filing is a framework I have identified as the Dual Capacity Problem — the distinction between Director Fox's conduct in his official board capacity, which carries institutional representation and protection, and his conduct as a private individual operating anonymous accounts, which does not. That distinction is now formally part of the administrative record before the Office of Open Records.

I am providing this notification to the Board for one purpose: to ensure that as elected officials with governance responsibility over this district, you are not without knowledge of what has been formally documented and submitted to a state administrative body.

No response is requested or expected. The record speaks for itself.

NOTICE OF SUPPLEMENTAL CONTEXT

Preservation of Record — Pending Appeal

Submitted by: John Ryan Miller | Cultural Contrarian | The Ordered Mind Project | Regulated Family

I. Purpose of This Notice

This notice is submitted solely to preserve supplemental context relevant to the pending appeal under Docket No. 2026-0167. I do not presently intend to initiate additional Right-to-Know requests concerning this specific communication chain unless necessary, and instead submit this notice to fortify the existing record with material developments that occurred on May 28, 2026.

No ruling, review, or advisory response is requested at this time. This submission is a record preservation measure.

II. Background: The Pattern of Conduct

The pending appeal concerns communications and conduct involving Brian P. Fox, a sitting Octorara Area School District Board Director representing Region 3. The record before this office reflects a documented pattern of systematic monitoring, reputational targeting, and interference with the advocacy activities of John Ryan Miller, a private citizen, dating from March 2022 to the present.

Central to the existing record is the documented dual capacity through which Director Fox has operated:

A. Official Capacity

Fox has utilized his institutional position, official email, and board authority to curate and distribute materials about Miller to law enforcement agencies including the Chester County District Attorney's Office and East Pikeland Police Department, and to create narrative documents designed to "anchor the discussion" in institutional settings.

B. Private Capacity via Alias

Fox has conducted a parallel campaign through anonymous alias accounts, most notably @LondonderryX123 on X.com. His identity as the operator of this account was established through formal DMCA counter-notification administrative records. This account was subsequently temporarily suspended by X.com for violations of platform harassment policies.

This dual capacity navigation is legally significant: the District's solicitor represents Director Fox in his official capacity. No solicitor representation attaches to Brian Fox as a private individual operating anonymous accounts. Fox has deliberately exploited this distinction to conduct activity that institutional representation would neither authorize nor protect.

III. May 28, 2026: The Escalation Sequence

The following sequence of events occurred on May 28, 2026 and constitutes the supplemental context submitted herein. Each event is documented by timestamped screenshot or email record and is available upon request.

Event 1 — Initial Posts (May 27, 2026, approx. 10:00 PM EST)

The account @LondonderryX123 published posts on X.com making the following false and defamatory claims:

- That John Ryan Miller “may record” private meetings without the knowledge or consent of participants, including meetings involving children.
- That counselors Martha Napolitana and Jessica Miller’s professional work is “suspect.”

These posts were screengrabbed sequentially beginning at 7:11 AM EST on May 28, 2026. See Exhibits A-1 and A-2. Exhibit A-1 shows the account with “Blocked” status visible, confirming Fox published content designed to reach Miller’s advocacy audience despite having been blocked. Exhibit A-2, captured at 7:21 AM, shows an edit indicator on the second post, suggesting modification between captures.

Event 2 — Cease and Desist Issued (May 28, 2026, 8:08 AM EST)

Miller issued a formal Cease and Desist notice to Brian P. Fox at brianfoxmail@gmail.com — the same contact information Fox provided in his

acknowledged response to a prior Cease and Desist on May 6, 2026 at 8:36 PM. The notice identified the posts as false and defamatory, documented the broader pattern of conduct, demanded removal of the posts, cessation of further conduct, and written confirmation of compliance. See Exhibit B.

Event 3 — Board Notification (May 28, 2026, morning)

Miller issued a parallel notification to the Octorara Area School District Board of Directors and Superintendent, informing them that a formal Cease and Desist had been issued to Director Fox regarding publicly defamatory statements made through a personal account. This notification was provided as a courtesy to ensure the institution was not without knowledge of conduct being conducted by one of its members in a public forum. All recipients were sent with Read Receipt confirmation. See Exhibit C.

Event 4 — Retaliatory Post Following Notice (May 28, 2026, approx. 10:20 AM EST)

Within approximately one hour of the Cease and Desist being sent, @LondonderryX123 published an additional post on X.com acknowledging Miller's claim that proper recording permissions were in place, then publishing a Google Drive link to what it characterized as a recorded call file: "2024 09 18 Miller Juisti Falg conf call.mp4," and tagging @parent_dome. This post was screengrabbed at 10:20 AM EST on May 28, 2026. See Exhibit D. The publication of this post after confirmed receipt of a Cease and Desist removes any claim of inadvertence.

Event 5 — Posts Removed (May 28, 2026, between 10:20 AM and 2:04 PM EST)

At 2:04 PM EST on May 28, 2026, Miller checked the @LondonderryX123 account and documented that all posts were no longer loading. The account profile remained intact — the "Blocked" status, the Google Drive background link, the join date, and follower counts were all still visible. Only the posts had been removed. See Exhibit E.

Post removal following formal notice and board notification is not compliance. It is damage control. The posts existed, were published to a public audience, accumulated documented impressions, and the retaliatory Exhibit D post was published after the Cease and Desist was received. The harm occurred prior to removal. The record was complete before the posts disappeared.

This pattern — publish, allow public exposure for a defined period, quietly remove — is consistent with prior documented conduct. Prior X.com harassment reports submitted by Miller regarding this account were declined by the platform. Documentation of those reports and platform responses is preserved separately.

IV. The Recording Claim: Factual Record

The claim that recordings were made without consent is false. Miller maintains consistent documentation practices as a lawful accommodation under the Americans with Disabilities Act. Every recorded conversation begins with explicit notice to all parties. Documentation confirming notice and consent for the September 18, 2024 call referenced in Exhibit D is preserved and available to any lawful reviewing authority. Miller declines to produce private communications in response to public claims by an individual with a documented history of misrepresenting such materials.

Miller possesses both the raw recording — which includes the notice exchange — and an edited version. Fox is publishing what appears to be the edited version while implying it represents a complete and unauthorized recording. The raw recording disproves this implication by its own existence.

Notably, the parties present on the September 18, 2024 call — Anthony Falgiatore, Officer Juisti, and Melissa Falgiatore — have filed no wiretapping complaint. They have not done so because they consented and are aware that documentation of that consent exists.

V. Relevance to Docket 2026-0167

The conduct documented herein is directly relevant to the pending appeal on the following grounds:

- Prior RTK requests have sought communications involving Director Fox in his official capacity. The dual capacity framework described in Section II is material to whether communications conducted through personal alias accounts — related to official district matters — are within the scope of required disclosure.
- The pattern of conduct documented across the existing record and this supplemental notice reflects systematic use of both institutional and private channels to manage narrative regarding Miller’s advocacy activities. That pattern is relevant to the completeness and good faith of any prior RTK response.
- The May 28 escalation sequence — occurring within hours of formal notice, followed by post removal before end of day — is evidence of willful and malicious conduct that the existing record contextualizes and the appeal record should reflect.

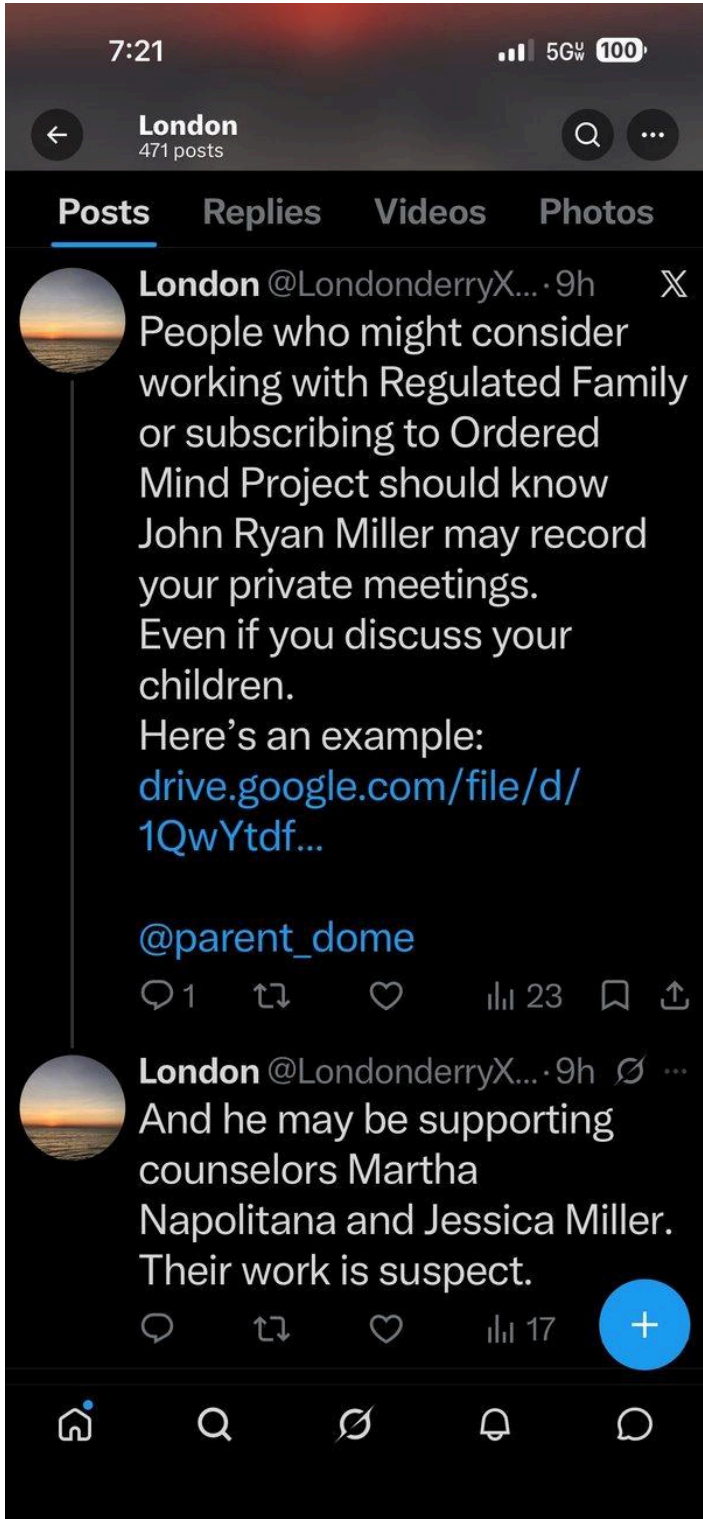

Cease and Desist Notice — Second Notice | Issued to Brian P. Fox | May 28, 2026

Subject: Notice of Defamatory Conduct and Demand to Cease and Desist — Second Notice

Mr. Fox,

This notice is provided for the record and serves as a formal second demand that you cease and desist from conduct that is defamatory, retaliatory, and harmful to named third parties.

You previously received and acknowledged a Cease and Desist notice on May 6, 2026 at 8:36 PM, regarding the unlicensed dissemination of copyrighted materials. You confirmed receipt and complied. That compliance is noted. What is also noted is that the underlying pattern of conduct did not stop.

On or about May 27, 2026, at approximately 10:00 PM EST, you published posts on X.com via the account @LondonderryX123 making the following false and defamatory claims:

- That John Ryan Miller ‘may record’ private meetings without the knowledge or consent of participants, including meetings involving children.
- That counselors Martha Napolitana and Jessica Miller’s professional work is ‘suspect.’

Both claims are false. Documentation confirming that proper notice and consent procedures were followed for any recorded sessions is on record and available. The claim that recordings occurred without consent is not a matter of opinion. It is a false statement of fact published to a public audience with the evident purpose of damaging professional reputations and discouraging families from seeking legitimate advocacy support.

You are identified as the operator of @LondonderryX123 through formal DMCA counter-notification administrative records. This is the same account previously suspended by X.com for violations of platform harassment policies. The resumption of

this conduct through this account, following that suspension, is not coincidental. It is a continuation.

The broader pattern from which this conduct emerges is thoroughly documented and spans from March 2022 to the present date. That record includes:

- Systematic monitoring and digital archiving of communications and social media activity beginning March 2022.
- Distribution of curated materials to law enforcement including the Chester County District Attorney's Office and East Pikeland Police Department.
- Direct contact with the East Whiteland Police Chief on November 11, 2022, expressing concern regarding a witness who had provided testimony on behalf of John Ryan Miller — conduct consistent with witness intimidation.
- Creation of timeline documents explicitly designed to 'anchor the discussion' in meetings with law enforcement and institutional stakeholders.
- Publication of private firearms records involving Miller's family members.
- Direct taunting of Miller's wife and daughter regarding financial matters and the prospect of criminal charges.
- Appearance as a Commonwealth witness in Case No. CP-15-CR-0003501-2022, Chester County Court of Common Pleas, while allegedly remaining in the courtroom in violation of the Court's sequestration order.
- Immediate post-verdict communication to district leadership recommending expansion of trespass restrictions.

You have had prior notice. You have demonstrated awareness of boundaries. The decision to utilize an existing account and resume this conduct following platform suspension and prior Cease and Desist compliance removes any claim of inadvertence. What remains is willful, malicious, and targeted conduct against a private citizen, his family, and his professional associates.

This notice demands the following:

7. Immediate removal of the posts published on or about May 27, 2026 via @LondonderryX123.
8. Permanent cessation of defamatory, retaliatory, or harassing conduct directed at John Ryan Miller, Jessica Miller, Martha Napolitana, or any associate of The Ordered Mind Project or Regulated Family.
9. Written confirmation of receipt of this notice and your intention to comply.

This notice is provided in good faith and in the spirit of direct resolution prior to any further action. That good faith is extended once. The documented record is complete, organized, and preserved.

You know who I am. You have known since March 2022. The record knows who you are as well.

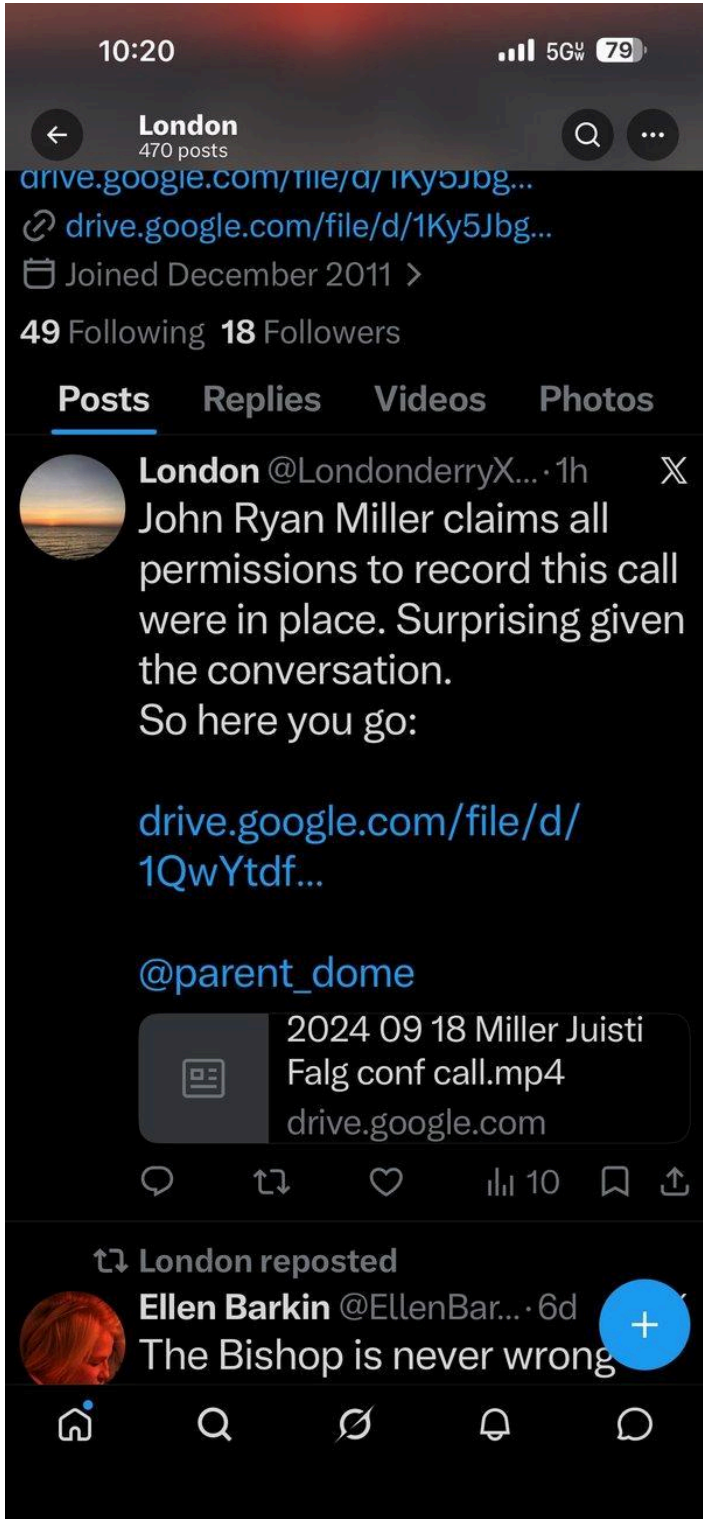
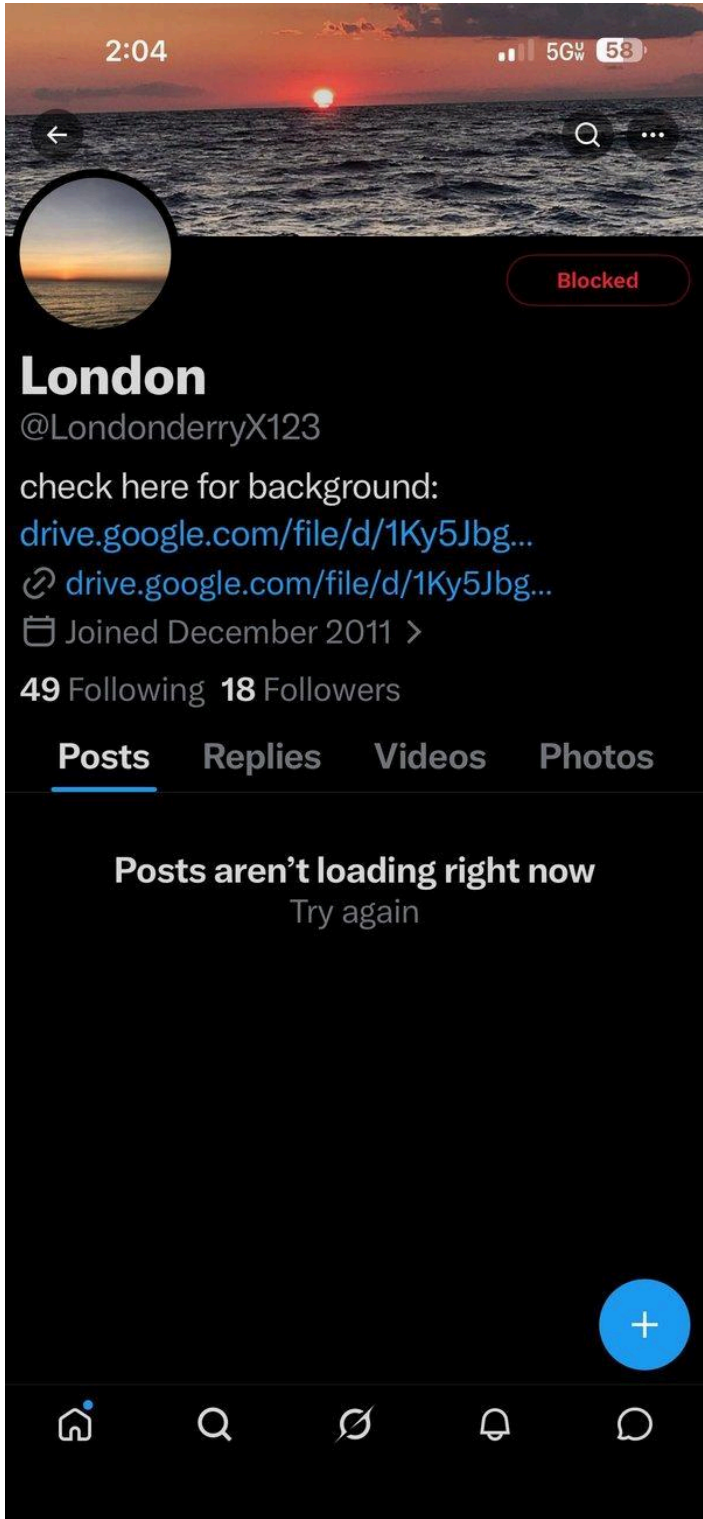
