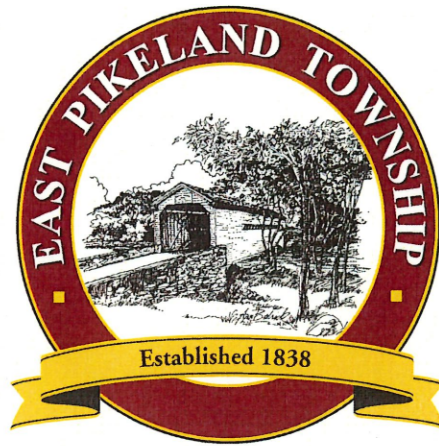

Source and scope

The Township's supplemental production consists of three scanned PDF files totaling 102 pages (scanned September 25, 2026). Most of those pages are repeated copies of the May 28, 2026 email and its 19-page attachment, a filing already submitted to the Office of Open Records under Docket AP 2026-0167. The pages above were selected because they carry the dates and statements the Registry entry relies on. The complete production is available on request.

Pages are reproduced as produced, except that a personal cell phone number appearing in an email signature has been blacked out on pp. 7–8. Nothing else has been altered or removed from the selected pages.

This packet documents what the records say and when they are dated. It does not establish why the June records were not identified in the August 17 response, what search was performed, or by whom. No finding of intent is made or implied.
